- **“EFFECTIVE PHYSICAL SECURITY”**

Most observable security measures are little more than a PERCEPTION OF SECURITY to persons not trained in the art and science of protecting lives and property. This course explains – in simple and understandable terms – the elements and components that are absolutely essential in order to establish effective security for any facility. This is a MUST ATTEND program for security management, decision makers and all persons with a responsibility for determining security measures.



- **“CONDUCTING SECURITY ASSESSMENTS”**

A fundamental task toward implementing or improving security for any facility is to first determine the threats, risks and vulnerabilities of the existing security program. This course provides the fundamental components for planning, preparation, documentation and execution of a security assessment project.



- **“SECURITY CONCEPTS FOR ARCHITECTS, PLANNERS & DESIGNERS”**

Many of the most critical security risks and vulnerabilities at a facility are nearly impossible – or very costly – to mitigate in the BUILT environment. This course provides the knowledge needed to avoid fatal errors at the concept, planning and design stage of any construction or development undertaking.



- **“CERTIFIED PROTECTION OFFICER (CPO)” [guard]**

This course prepares attendees for the written examination to become a *Certified Protection Officer* (CPO) by the International Foundation for Protection Officers (IFPO) based in the United States. This course uses *“The Professional Protection Officer: Practical Security Strategies and Emerging Trends”* (current edition) publication and includes the mid-term and proctored final examination.



- **“CERTIFIED PROTECTION OFFICER INSTRUCTOR (CPOI)”**

Those seeking to become instructors (CPOI) must first become certified as a CPO. This course prepares CPOs for the role of security instructor and also guides each through the applications process with the IFPO



- ***“PROFESSIONAL SECURITY GUARD PRIMARY TRAINING”***

Security guard training is among the most overlooked elements of effective security for any facility. This is a COMPREHENSIVE training program for both new and experienced security personnel, covering all of the basic subjects needed for any assignment.



- ***“SECURITY AWARENESS FOR NON-SECURITY EMPLOYEES”***

Effective security at any facility is significantly and substantially improved by security awareness training for all facility employees. This course is intended to teach personnel how to recognize suspicious behavior, activities and conditions that may indicate threat to security of the facility and what to do about it. Security awareness increases the chance of discovering potential threats during an adversary’s surveillance stage.



- ***“DEVELOPING SECURITY POLICIES, STANDARDS & GUIDELINES (PSG)”***

Along with a Security Assessment, the most important task in establishing or improving any facility security program is the writing of a comprehensive and effective security policies, standards and guidelines document. This course explains the content, structure and process of producing a world class document implementing global best practices for any facility or enterprise.



- ***“FIRE ALARM & LIFE SAFETY SYSTEMS INTERNATIONAL CODES & STANDARDS”***

This course takes attendees through the essential and critical requirements of the most used and recognized international codes and standards for electronic fire alarm and life safety systems. The complex technical aspects are made clear and understandable to improve the attendee’s ability to plan such systems and to evaluate existing systems for compliance.



- ***“SECURITY LICENSING & REGULATION for Government Regulators”***

Licensing or similar government regulation of security services and products providers has proven very beneficial to industry, consumer and government alike, but ONLY if implemented and operated effectively. This course presents the essential elements for such a program along with “model” laws and other components that set the international benchmark in raising the quality and professionalism of the security industry.



- **“MARITIME PORT AND SHIP SECURITY UNDER THE ISPS”**

Certificated courses in accordance with IMO's *International Ship & Port Security* requirements are available at 3 levels. Each session is supplemented with material on any specific and different requirements applicable within a designated country. The courses are;

- **“INTERNATIONAL LOGISTICS & SUPPLY CHAIN SECURITY”**

- ISO 28000: *Specification for Security Management Systems for the Supply Chain*
